### **RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

**IN CONSIDERATION** of being permitted to enter for any purpose any **RESTRICTED AREA** (herein defined as including but not limited to the rodeo arena, competition area, chutes, pens, areas reserved and intended for participants or restricted to the event shall take place), or being permitted to compete, officiate, observe, practice, training, work for, or for any purpose participate in any way in the event **EACH OF THE UNDERSIGNED**, for himself / herself, his/her personal representatives, heirs, and next of kin, acknowledges, agrees and represents that he/she has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted area and all portions thereof which he/she enters and with which he/she come in contact, and he/she does further warrant that his/her entry upon such restricted area or areas and his/her participation, if any, in the event constitutes an acknowledgement that he/she has inspected such restricted area and that he/she finds and accepts the same as being safe and reasonably suited for the purpose of his/her use, and he/she further agrees and warrants that if, at any time, he/she is in or about restricted areas and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and will liable the restricted areas.

1. **HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE** the participants, sanctioning organization or any subdivision thereof, rodeo committee, stock contractor, rodeo association, arena operations or owners, officials, any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as "releases", from all liability to the undersigned, his/her personal representatives, assigns, heirs and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury so the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is in or upon the restricted area, and/or, competing, officiating in, observing, working for, or for any purpose participation in the event.

2. **HEREBY AGREES TO INDEMNITY AND SAVE AND HOLD HARMLESS** the releases and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restrict area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releases or otherwise.

3. **HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE** due to the negligence of releases or otherwise while in or upon the restricted and/or while competing, officiating observing, or working for or for any purpose participating in event expressly acknowledges and agree that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage. **EACH OF THE UNDERSIGNED** further expressly agrees that the foregoing release, Waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the province continue in full legal force and effect.
